I hereby release and forever discharge PRH from any and all rights, claims, obligations, liabilities, and causes of action whatsoever arising out of or relating to the ownership, possession, or disposition of the PRH, and I agree to indemnify and hold harmless PRH from and against any and all such rights, claims, obligations, liabilities, and causes of action which may be asserted by third parties.
This is a legally binding document for the irrevocable surrender of your Bird to PRH.
