I have disclosed to PRH **all** material information regarding the medical and behavioral history of the Bird. I willfully surrender all medical records and information pertaining to the Bird. PRH has my permission to contact my veterinarian for any necessary information pertaining to my Bird, and I hereby consent to the release of any and all medical information by any medical provider.

I hereby release and forever discharge PRH from any and all rights, claims, obligations, liabilities, and causes of action whatsoever arising out of or relating to the ownership, possession, or disposition of the Bird, and I agree to indemnify and hold harmless PRH from and against any and all such rights, claims, obligations, liabilities, and causes of action which may be asserted by third parties.

This is a legally binding document for the irrevocable surrender of your Bird to PRH.
